# Suburban Hospital expansion update

There have been several developments on the Suburban legal front since the Oct. 3 community meeting. You will recall that members of the Huntington Terrace Citizens' Association (HTCA) voted 41-23 to appeal the decision of the Maryland Court of Special Appeals (COSA). Our lawyer, Norman Knopf, was authorized to proceed with the appropriate court filings. There was also support to renew negotiations with the hospital (although no specific vote was taken on that point).

- COSA rejected the motion to reconsider on Oct. 31.
- On Nov. 14, our lawyer filed a writ of certiorari with the Maryland Court of Appeals. This action requests that the court hear the HTCA case. It's not clear how long the court will take to decide whether it will accept the case. Suburban says the court has 60 days from November 26, the date the hospital filed a response to the HTCA petition; our lawyer says he is unaware of any limit but that action within 60 days is likely.
- Allan Gold, HTCA's president, met with Dr. Gene Green, Suburban's president, on Nov. 11, and asked about the possibility of further negotiations. Dr. Green said the hospital would decline the invitation to re-open negotiations. Dr. Green said the hospital expects to break ground on the project in fall 2014, assuming that the Court of Appeals doesn't accept the HTCA case.

### Other news:

- -- The HTCA and Bradmoor Neighborhood Association have asked the Montgomery County Department of Parks to install two water fountains in Bradley Park. The parks department will be making a new playground in the park, closer to Madison Street than in the past.
- -- The HTCA has asked the Montgomery County Department of Transportation to explore installing stop signs on Garfield Street, at the corner of Southwick Street, or other trafficcalming measures on Garfield Street.
- -- The county's Bikeshare program has come to Huntington Terrace. The county has installed 19 docks at the corner of Old Georgetown Road and Southwick Street. For more information on the program, see

- -- Some residents may have noticed more late mail deliveries than normal. If you have delivery issues, the supervisor for the 20817 zip code is Ms. Frierson at the Westlake Post Office and can be reached at 301 767 1742
- -- Several homes are under construction in Huntington Terrace, and some neighbors have

been disturbed by supply deliveries at very early hours. It's clear that some contractors and subcontractors don't follow "best practice" or adhere to the county noise regulations. When all else fails, there's compliance through inspections and fines. Residents can call the Department of Environmental Protection at 240-777-7700 from 8 a.m. to 4:30 p.m. weekdays.
