#### NOTICE OF NEW HEARING DATE

Please take notice that the Board of Appeals for Montgomery County, Maryland, will hold a public hearing, on Wednesday, the 11<sup>th</sup> day of September, 2024, at 9:30 a.m., or as soon thereafter as this matter can be heard, on the application filed pursuant to Section 59.7.3.2.A of the Zoning Ordinance.

The proposed construction, an addition to an existing detached accessory dwelling unit, requires a variance of 19.71 feet as it is within twelve (12) feet of the rear lot line. The required setback is 31.71 feet, in accordance with Section 59.3.3.3.C.2.c and d of the Zoning Ordinance.

In addition, the proposed construction requires a variance of 610.28 square feet as it has a total gross floor area of 1098.29 square feet. The required maximum gross floor area is 488.01 square feet, in accordance with Section 59.3.3.3,C.2.e.i of the Zoning Ordinance

In the case of a major modification to a special exception, a copy of the applicant's complete submission will be referred to the Montgomery County Planning Board for review and recommendation. Maryland law requires that corporations and entities other than individuals, recognized in Maryland law as persons, be represented by an attorney in legal and quasi-judicial proceedings [See Maryland Rules 1-202(u)].

Groups and organizations and individuals represented by counsel who wish to testify at a hearing must file two copies of their statements at least 10 days before the scheduled hearing date. Their statement must indicate what they expect to prove, the names of witnesses, the estimated time for presentation of the case, resumes of expert witnesses and summaries of their testimony, and any formal reports prepared by expert witnesses. An individual may testify on his or her own behalf without prior notice either in favor of, or in opposition to, the special exception or variance.
